20.	Bar Council of India vs. A.K. Balaji	Foreign law firms /lawyers cannot practice in India but casual visit on fly in and fly out basis is permissible.
21.	Board of Control for Cricket in India (BCCI) vs. Kochi Cricket Pvt. Ltd.	Arbitration and Conciliation (Amendment) Act, 2015 is prospective in nature)
22.	Shafin Jahan vs. Ashokan K.M.	Hadia Case (in this case Supreme Court set aside Kerala High Court judgement which annulled Hadia's Marriage)
